WHEREAS, the Housing and Economic Recovery Act of 2008 (HERA) was signed into law on July 30, 2008, and

WHEREAS, Title III of Division B of HERA appropriates funding for the Neighborhood Stabilization Program (NSP) which provides emergency assistance for the redevelopment of abandoned and foreclosed homes; and

WHEREAS. The County of Washington (the County) is eligible to apply for federal NSP funding through the Pennsylvania Department of Community and Economic Development (PA DCED); and

WHEREAS, NSP funds will be awarded by PA DCED on a competitive basis; and

WHEREAS, PA DCED has published a list of census tracts in the Commonwealth of Pennsylvania that have been severely impacted by foreclosure; and

WHEREAS, in order to ensure the competitiveness of its NSP application, the County has selected target areas for NSP revitalization activities that include the Borough of Charleroi; and

WHEREAS, NSP funding is being sought by the County to acquire, demolish, rehabilitate and/or newly construct housing on vacant, abandoned and foreclosed properties located in the Borough of Charleroi, and

WHEREAS, the objective of the County's NSP program is to create or preserve housing that is affordable to households up to 120% of area median income.

NOW, THEREFORE, BE IT RESOLVED, that the Borough of Charleroi supports the County of Washington's application for financial assistance under the Commonwealth of Pennsylvania's Neighborhood Stabilization Program.

#### Neighborhood Stabilization Program Borough of Charleroi

The Housing and Recovery Act of 2008 allocated \$3.9 billion in Neighborhood Stabilization Program (NSP) Funds for state and entitlement communities for the purchase and redevelopment of abandoned and foreclosed homes. The Commonwealth of Pennsylvania, through the Department of Community and Economic Development (DCED), has been allocated \$59.6 million in NSP Funds and has established guidelines for eligible applicants to apply for NSP Funds. The County of Washington is an eligible applicant for funding under the Commonwealth's NSP guidelines and intends to submit an application for funding by the January 23, 2009 deadline.

The PA DCED published a list of census tracts in the Commonwealth that have been severely impacted by foreclosed properties. The Borough of Charleroi is one of the municipalities within the County that has a high foreclosure and abandonment risk score as determined by DCED. Therefore, the County would like to target the Borough of Charleroi with the NSP funds.

The NSP funds can be used for the acquisition and rehabilitation of abandoned foreclosed properties. New houses can also be constructed on vacant lots under the program. Washington County's NSP application will request approximately \$500,000 for the Borough of Charleroi. The County's NSP program will utilize Mon Valley Initiative, a non-profit housing development agency, to undertake the activities of the program. It is anticipated that five properties will be redeveloped in the Borough of Charleroi.

NOW, THEREFORE, BE IT RESOLVED and it is hereby resolved by the Borough Council of the Borough of Charleroi that effective January 1, 2010 and continuing through and including December 31, 2010, the amount of Participant Contributions due shall be zero percent (0%) of compensation. The obligation to pay Participant Contributions pursuant to Act 600 shall resume effective January 1, 2011.
