Part Time Street Position

Duties may include, but are not limited to, the following and will be performed in a safe and responsible manner:

- Cleans and removes debris from streets, gutters, storm drains, catch basins, drainage ditches, sidewalks, and street construction sites by shoveling, raking, sweeping, and picking up debris.
- Breaks up pavements, digs holes, cuts trenches, excavates and fills in holes in streets and other paved surfaces, using sledge hammer, shovel, pick, spade, rake, hoe, hand tools or jackhammer; patches and paves streets and other paved surfaces.
- Loads, transports, and unloads construction equipment, materials, debris, and other heavy objects related to street maintenance, using appropriately sized vehicle and/or tractor with mower, loader, or backhoe attachments.
- Builds forms and prepares surfaces for paving, patching, or repair/reconstruction of streets, curbs, and similar public works facilities.
- Installs, repairs, and replaces storm drain pipe, street signs, traffic markers, street benches, end barriers, guard rails, or other related objects.
 Operator apphalt rake, power roller and band tools, mixing, apphales, leveling, or othermice.
- Operates asphalt rake, power roller and hand tools, mixing, applying, leveling or otherwise finishing concrete, asphalt or other such material to repair, replace, or reconstruct broken pavement.
- Paints traffic markings on streets, crosswalks, parking lots, curbs, using stencils, legends, striping and taping equipment.
- 8. Fabricates, installs, and repairs traffic/street signs and removes those no longer needed.
- 9. Designs and fabricates special signs for municipal facilities, as needed.
- 10. Operates power street sweeper; maintains and replaces sweeper brooms and liquids.
- Learns to operate small, medium, and large trucks as assigned during a variety of weather conditions. Position may include operating truck with plows and salt spreaders.
- 12. Sets up traffic control including signs and barricades, and directs traffic around work sites.
- 13. Performs routine preventive maintenance on equipment as necessary.
- 14. May remove dead animals from rights of way as necessary.
- 15. Cleaning of spills, garbage, and general cleaning of municipal facilities and equipment.
- 16. Perform maintenance on Borough facilities.
- 17. Vehicle maintenance and repair.

"The Drama Continues" As the governing body of the Town of Charleroi, it's time we take action on the on-going, never ending saga of the Coyle Theater project. The ever-changing members of the Board of the MMVCT continue in an attempt to enlist

support from non-Charleroi residents. A few so called "experts" from out-of-town, even out-of-state, have offered suggestions for renewal, but to date no formal plan of action has been implemented, nor even if some funding is secured by the Trust, could the time frame go on for another very long period of time.

As leaders of our community, catering to this Board exceeds the bounds of reason there is a lack of substance or validity to their claims.

Since the year 2000 the Trust has failed to perform according to their by-laws. Council should seek a more promising economic development strategy. An improved tax base and the outgrowth of quality employment should be our goal.

Let's hope a three generation local family industry will make its corporate home in the city of its birth. If not at the Coyle site, the 3rd Street location could be appropriate if financially feasible.

However, this would not eliminate the unreasonable actions of the Trust. This situation has become ludicrous, even embarrassing at times. Let's not let it go on leading merchants and residents to believe that we approve.
